**Notice to Exhibitors**

**Ribbons: Qualifiers in all classes will receive flat ribbons.**

**Bitches in season are not eligible for entry.** Entry fees will not be refunded. Bitches in season must not be allowed to interfere with the running of the tests.

**All dogs are to be held on short leash and under control while on the test's grounds.** For everyone's safety, dogs shall NOT BE LEFT UNATTENDED in exercise pens while on the grounds.

**Spectators** may be allowed to view the test from an area predetermined by the TEST Judge, provided that they are quiet and do not distract the dogs. No dogs shall be allowed within 100 feet of the test areas.

**Confirmed entrants not present** at the testing area when their number is called will be moved to the end of the test order.

**Returned checks do not constitute a valid entry fee.** Fees must be reimbursed in guaranteed funds. Checks will not be accepted. The Farm Dog Secretary will add a collection fee of \$25 to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY

basis. Any awards won by dogs with invalid entries because of NSF will be rescinded unless the club is reimbursed immediately.

## **Directions to the Test Site**

### **Heading from either south or northbound on I-205:**

Take exit 10 for OR-213 toward- Mollala/Oregon City

Follow OR-213 for about 3 miles and turn left onto Beavercreek Road. Follow Beavercreek Road about 3.7 miles.

In downtown Beavercreek, Beavercreek Road makes a 90-degree left turn at a four-way intersection. Make a left turn to stay onto Beavercreek Road. Continue about 5 more miles on Beavercreek Road. Turn right on S. Larkin Road. There will be a sign on the telephone pole beside the driveway for 24491. Turn right down the long driveway, just in front of the telephone pole with the sign. The driveway splits into 2 driveways. There is a gate to the right-hand driveway, and this is the neighbors. Please do not disrupt them.

The driveway eventually turns to the left. Parking will be at right angles to the driveway past that left turn, with overflow parking into 2 fields that will be marked.
